Certificate of exemption from tax deduction in the case of construction works pursuant to § 48 b subs. 1 clause 1 of the Income Tax Act (EStG)

As regards

it is herewith confirmed that the recipient of the construction works (recipient of performance) is exempted from the obligation to deduct taxes pursuant to § 48 subs. 1 EStG.

This confirmation is valid **from 01.01.2014 until 31.12.2016**.

Important information:

The original of this confirmation must be handed over to the recipient of performance in case it applies to certain construction works. In case the confirmation is valid for a period of time, it is also possible that only a copy is handed over. The original must bear the official seal, signature and security code.

The recipient of performance has the option to gain certainty about a possible liability risk by checking the validity of the certificate of exemption. This may be done via an internet inquiry with the Federal Central Tax Office (www.bzst.de). For this purpose the data are stored with the Federal Central Tax Office and disclosed to the recipients of performance upon internet inquiry. If the Federal Central Tax Office does not confirm validity or if the recipient of performance cannot perform an internet inquiry, he can gain certainty by an inquiry with the tax office indicated on the certificate of exemption. Failure to perform an internet inquiry with the Federal Central Tax Office or an inquiry with the tax office **alone** does not constitute gross negligence resulting in any liability. The exemption from the obligation to deduct taxes applies for payments that are made within the above-mentioned validity period and/or for the above-mentioned construction works. Offsetting (compensation) by the recipient of performance with counterclaims vis-à-vis the provider is the equivalent of a payment.

This confirmation may be withdrawn.

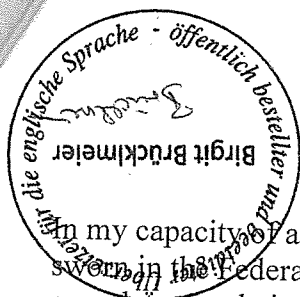
